



For Republic of Ireland landlords home insurance policy wording reference: LETI/0122/PW

The following document demonstrates any significant differences to the conditions of the policy and the cover between the September 2021 policy wording, with a wording reference of LETI/0921/PW, and the January 2022 policy wording, with a wording reference of LETI/0122/PW.
